For full and complete compensation of \$ _____, I, _____ agree to perform, model, or otherwise be present and filmed, interviewed, or otherwise recorded during the filming of a motion picture tentatively titled _____. I further agree as follows:

All videos, motion-picture films, or master sound recordings made for or by Yellow Jacket Productions, Inc. or by you for Yellow Jacket Productions, Inc. under this Agreement from the inception of filming or recording, and all matrices, videos, film, phonograph records, or any other media now known or hereafter developed for the sale or distribution of motion picture films, videos or records together with the performances embodied on them, (collectively referred to hereinafter as "Film and/or Master"), and all artwork created for use in connection with such Media shall be the sole property of Yellow Jacket Productions, Inc., free from any claims by you or any other Person; and Yellow Jacket Productions, Inc. shall have the exclusive right to copyright such Film and/or Master in its name as the author and owner of them and to secure any and all renewals and extensions of such copyright throughout the world. To the extent, if any, that you may be deemed the "author" of any such Film and/or Master you hereby grant to Yellow Jacket Productions, Inc. a power of attorney, irrevocable and coupled with an interest, for you and in your name, to apply for and obtain, and on attaining same, to assign to Yellow Jacket Productions, Inc. all such copyrights and renewals and extensions thereof. You will execute and deliver to Yellow Jacket Productions, Inc. such instruments of transfer and other documents regarding the right of Yellow Jacket Productions, Inc. in the Film and/or Master subject to this Agreement as we may reasonable request to carry out the purpose of this Agreement, and Yellow Jacket Productions, Inc. may sign such documents in your name and make appropriate disposition of them. Yellow Jacket Productions, Inc. will give you ten(10) days notice before signing any such document in your name. Yellow Jacket Productions, Inc. may dispense with that waiting period when necessary, in Yellow Jacket Productions, Inc.'s judgement, to protect or enforce its rights, but Yellow Jacket Productions, Inc. will notify you in each instance when it has done so. Yellow Jacket Productions, Inc. will not be required to notify you before signing applications for copyright and/or short form assignments or right granted in this Agreement for recordation in the Copyright Office. All artwork or Film and/or Master shall contain all such trademarks, trade names, information, logos and other items, as Yellow Jacket Productions, Inc., customarily includes on such materials.

Without limiting the generality of the foregoing, Yellow Jacket Productions, Inc. and any Person authorized by Yellow Jacket Productions, Inc. shall have the unlimited, exclusive rights, throughout the world: (a) to manufacture and/or distribute any Film and/or Master in any form and by any method now or hereafter known, derived from the Film and/or Master made or Delivered under this Agreement or during its term; (b) to sell, lease, rent, transmit, import, export, transfer or otherwise deal in or dispose of the same under any trademarks, trade names and Yellow Jacket Productions, Inc. or imprints, or to refrain from such manufacture, sale and dealings; (c) to reproduce, adapt, and otherwise use any Film and/or Master in any medium and in any manner, now known or hereafter developed.
